3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the programmes as indicated in the above table does not imply that the accreditation has been granted to **Vivekanand Education Society's Institute of Management Studies & Research, 495-497, Near Municipal School, Collectors Colony, Chembur, Mumbai-400074, Maharashtra** as a whole. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.

8. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
